III. ACCORDINGLY THESE PRESENTS WITNESSES AS FOLLOWS:

That Loka Seva Vrinda hereby creates a Trust by the name of Sri Sathya Sai Loka Seva Trust (hereinafter referred to as the 'Trust') with the objects and upon the terms and conditions hereinafter mentioned.

The founder hereby transfers unto the sole Trustee of the Trust, namely Bhagavan Sri Sathya Sai Baba, the various properties belonging to the Society and described in the Schedules written hereunder together with the liabilities listed herein in Schedule III.

The Schedule properties as also any other properties movable or immovable, monies, securities, donations received or acquired by or in the name of the said Trust from whatever source and all addition and accretions thereto and income therefrom and every part thereof shall [shall] stand vested in the Trustee upon Trust subject to the provisions hereon. The Trust shall discharge the liabilities transferred to it as aforesaid.

OBJECTS

IV. The objects of this Trust are:

- 1) to promote education; a) by the establishment and running of Schools, Colleges, Libraries, Hostels; b) .....

TRUSTEE

VII. Bhagavan Sri Sathya Sai Baba shall be the Sole Trustee. After he sheds his mortal coil, the persons nominated by him shall be Trustees and they shall hold office for such periods as the Bhagavan may have fixed. In the absence of fixation of my Tenure, the Trustee/s so nominated by him shall hold office for life. Vacancies occurring in the Office of Trustee after Bhagavan shall be filled by the Remaining Trustees in Office and if no one such is in Office, then the nominee/s of Sri Sathya Sai Trust, (Karnataka) shall be the Trustee/s:

VIII. The Sole Trustee may constitute from time to time, a Council of Management and/or a Committee or Committees to assist him in the management of the affairs

and properties of the Trust and its institutions. The tenure and personnel of the said committee or Committees and the duties to be rendered by them shall all be as laid down by and in the absolute discretion of the Sole

DELEGATION/RULES & BY-LAWS

VIII. The Sole Trustee, may in his absolute discretion, from time to time, delegate to any others, any of his powers, functions or duties in respect of this Trust; and he may also frame rules and by-laws for the management of the Trust and its institutions and amend or rescind them from time to time.

POWERS OF THE TRUSTEE/S

IX. The Trustee/s shall have full power and authority to administer the Trust, its properties and funds and to do all acts, deeds or things as are calculated to promote the objects of the Trust.

Without prejudice to the generality of the said powers, the Trustee/s shall have power;

- a) to acquire, hold and dispose of properties;
- b) to sell, mortgage and grant leases;
- c) to borrow monies with or without securities;
- d) to open Bank accounts and provide for their operations;
- e) to enter into contracts and rescind them;
- f) to appoint, terminate, suspend and otherwise deal with the employees of the Trust; and all its institutions; .....

- a) to institute and defend all suits and proceedings;
  - b) to appoint any Agent/s and delegate to him/them such of the powers of the Trustees as he deems fit;
  - c) to invest the funds of the Trust in such manner as he deems fit, without being subject to limitation of section 20 of Indian Trust Act.

IRREVOCABILITY & AMENDMENTS

X. The Trust hereby created is irrevocable. The provisions hereof may be amended by the Trustee/s in Office from time to time without however affecting the character of the Trust as one established for the objects hereinabove set forth.

FAILURE OF TRUST

XI. If for any reason this Trust shall fail or it is resolved to dissolve this Trust, the Trustee/s in Office at the time of dissolution/failure may transfer the properties/funds of the Trust to the Sri Sathya Sai Trust, (Karnataka) or any other trust having similar objects.

ACCEPTANCE

XII. Bhagavan Sri Sathya Sai Baba is hereby pleased to accept this Trust.
